Dear Prospective Summer Fest Competitor,

Last year (2009) we had an overwhelming desire by teams to participate in Summer Fest. We had to turn several teams away. 72 teams is our absolute limit. We cannot physically handle anymore. In light of that, we have made a mailing to all of last year's 72 competitors advising them that they have until April 1 to reserve a spot at this year's Summer Fest. After that, it will be first come first served.

Since you weren't here last year but may have a desire to participate this year, here's how we are going to handle that.

We will accept completed forms and money and hold them until after April 1. You must send money in the form of cash, check or money order in order to be considered. We will sequence requests as we receive them and then after April 1 we will notify you whether you have made the magic list of 72. If you don't make it, we will hold you on the waiting list until the event as we usually get several late cancellations and if not, we will return your check or money order.

We have eliminated the Sausage category and replaced it with Chili. You can make your favorite chili, any style, any garnish you wish. You must be willing to eat your own chili. You will be given 6 individual containers with lids (1 for each judge) and those are to be placed in a turn-in container provided by Summer Fest. Chili will be judged last (2:00 PM) and Chef's Choice will be judged first (11:30 AM). If you have any questions with the chili entry, e-mail Dave (Red) Todd at redtodd@comcast.net.

Site must be torn down and free of litter by 8:30 PM Saturday night. **No Alcohol allowed on Park Property.** All **Food** Venders must show proof of liability insurance naming KCBS and New Holland Community Memorial Park as additionally insured.
