Also, judge status must be 'current' at check-in table at the event. **Please note**, the first 90 applications received will be seated to judge, table captain or serve as a volunteer; the rest will go on a 'Standby List' as they are received.

Applicants will receive **two (2) notifications of acceptance or standby list** placement, which will be done when the judging list is completed and a final confirmation 7-10 day prior to the event. Accepted judges should plan to arrive and signed in by 10:00 AM, on Saturday August 29<sup>th</sup>. Judge **MUST** be present for the entire judges meeting in order to be seated.

### **TERMS & CONDITIONS:**
